## ICPSR CODEBOOK NOTES

### Part 6: New York State Criminal Record/Fortune Society Client Match Data

- 1) The data are restricted from general dissemination. Users interested in obtaining these data must complete a Restricted Data Use Agreement form and specify the reasons for the request. A copy of the Restricted Data Use Agreement form can be requested by calling 800-999-0960. Researchers can also download this form as a Portable Document Format (PDF) file from the download page associated with this dataset.

- 2) Part 6 is comprised of 96,009 records which identify matches between a New York State criminal record identifier and a Fortune Society client identifier. Specifically, Part 6 contains the NYSIDALIAS "ABT GENERATED NYS CRIMINAL RECORD IDENTIFIER" and FORTUNEALIAS "ABT GENERATED FORTUNE CLIENT IDENTIFIER" variables, which can be used to link Part 6 to other data parts in this data collection, and the BAD\_DUP "NYSID THAT MATCHES TO A FORTUNE CLIENT, BUT THAT MATCH IS NOT UNIQUE" variable which identifies the record as unique, ambiguous, or not matched. Additionally, ICPSR created the CASEID "CASE IDENTIFIER CREATED BY ICPSR" variable, which is a unique identifier for each line (i.e. record) in that data file. The datasets cannot be linked using the CASEID variable.
- 3) ICPSR added the following variable labels based upon information provided by the principal investigators:
