The 2011 Annual Probation Survey provides a count of the total number of persons supervised on probation on January 1 and December 31, 2011, and a count of the number of persons entering and exiting probation supervision during 2011. The survey also provides counts

of the number of probationers by certain characteristics, such as gender, race and Hispanic or Latino origin, offense, and supervision status. The survey covers all 50 states, the District of Columbia, and the federal system.

#### Respondents:

The 2011 Annual Probation Survey was sent to 469 respondents: 33 central state reporters; 436 separate state, county, or court agencies, including the state probation agency in Pennsylvania, which also provided data for 65 counties in Pennsylvania; the District of Columbia; and the federal system. The states with multiple reporters were Alabama (3), Arizona (2), Colorado (8), Florida (41), Georgia (2), Idaho (2), Kentucky (3), Michigan (136), Missouri (2), Montana (4), New Mexico (2), Ohio (187), Oklahoma (3), Tennessee (3), Washington (32), and West Virginia (2). One locality in Colorado, two in Florida, seven in Michigan, thirteen in Ohio, two in Washington, and the central reporter in New Mexico did not provide data for the 2011 collection. For these localities, the agency's most recent December 31 population was used to estimate the January 1 and December 31, 2011, populations.

The Bureau of Justice Statistics depends entirely upon the voluntary participation of State Central reporters, and separate State, county, or court agencies for the annual probation survey. Because many jurisdictions update their population counts, the January 1, 2011, numbers may differ from those previously published for December 31, 2010.

Since 1995 the survey coverage has been expanded to include 175 additional local agencies in Ohio (131), Florida (27), Washington (11), Montana (3), Kentucky (2), and Idaho (1). The majority of agencies (161) were added in 1999.

For additional changes in reporting within particular jurisdictions since 2000, users should refer to BJS' annual bulletin series Probation and Parole in the United States beginning with the 2008 bulletin. #### Changes in Collection of Information on Race and Hispanic Origin:

Several changes have occurred in how data on race and ethnicity have been collected by the Annual Probation Survey since 1994:

- 2005

- A response category was added for "Two or more races (not of Hispanic origin)" (variable name TWORACE).

- The response category "Not known" was added (variable name UNKRACE).
- 2001
  - A single item was first used to collect information on both race and Hispanic origin, replacing two separate items which had been used in 2000 and prior years. Consequently, starting in 2001, the following variables exclude persons of Hispanic origin: WHITE (response category "white"), BLACK (black/African American), AMINALK (American Indian/Alaska Native), AMINALK (Native Hawaiian/Pacific-Islander), and ADDRACE ("Additional categories in your information system"). Before 2001, these same variables include persons, by race, of Hispanic and non-Hispanic origin; e.g. prior to 2001, the variable WHITE includes whites of Hispanic and non-Hispanic origin, etc.
  - Counts of persons of Hispanic origin, regardless of race, are reported by the variable HISP, both before and after 2001. Before 2001, separate counts were also obtained for those who were not of Hispanic origin (NOTHISP).
  - The response category "Additional categories in your information system - Specify" replaced the category "Other categories in your information system - Specify". Both are reported with the same variable name (ADDRACE).
- 1999
  - The response category "Other categories in your information system - Specify" replaced the category "Other - Specify" in the item which collected information on race. Both are reported with the same variable name (ADDRACE).
- 1998
  - Two separate response categories "Asian" (variable name ASIAN) and "Native Hawaiian/Pacific Islander" (HAWPAC) replaced the single category "Asian/Pacific Islander" (ASHAWPAC). Variables ASIAN and HAWPAC appear in archive files for 1998 and later; the variable ASHAWPAC appears in archive datasets for 1997 and earlier.

Variables provide information on the number of probationers by certain characteristics, such as gender, race and Hispanic or Latino origin, offense, and supervision status.

*Extent of Processing Checks:* ICPSR performed checks for undocumented codes and prepared SAS, SPSS, and Stata setup files and SAS transport, SPSS and Stata system files.

### Notes

1. Data in this file may not be comparable to previously published BJS reports or statistical tables. Some data may have been updated since its initial release. In addition, several variables from the survey may have been combined and reported as a single figure in prior BJS reports or statistical tables. For example, "unknown", "calculated unknowns", and "other" variables may have been combined and "completions" (EXCOM) and "discharge other completion" (EXOTHCOM) may have been combined and reported as a single figure. For the item on race (item7), BJS reporting of unknown race includes the separate unknown race item on the survey (UNKRACE - item7i), additional categories of race in the information system (ADDRACE - item7h), and the BJS calculated unknown variable (UNKRACE2). In addition, BJS reporting combines other incarceration (EXINCOTH - item3b4) and unknown other incarceration (EXINCUNK - item3b5) to report "incarceration other/unknown".

2. Because of how data were analyzed and combined, some "0" entries in numerical fields may reflect missing data rather than true zeros for jurisdictions with multiple reporters.

3. Some items were not asked of all respondents. The following critical survey items were always asked: TOTBEG (item1), TOTEN (item2e), TOTEX (item3i), TOTEND (item4), INORCASE (item5), MALE (item6a), FEMALE (item6b), GENDUNK (item6c), TOTGEND (item6d), FELONY (item8a), MISD (item8b), OTHSROFF (item8c), SROFFUNK (item8d), and TOTSROFF (item8e). For these items, "unknown" means the respondent did not provide an answer. For all other items, "unknown" could also mean that the question was not asked.

4. Skipped items in the data were interpreted as an implied "don't know" by the data producer and recoded as such.

5. Item numbers in variable labels and question text correspond to items on the survey instrument.
