Scope of Study

Summary: The California Work Pays Demonstration Project (CWPDP) was intended to assess the effects of recent changes in Aid to Families With Dependent Children (AFDC) provisions. The project documents the dynamics of family poverty and welfare use in California. Part 1, Overview Data: Cases contains one record for each CWPDP case sampled between October 1992 and March 1997. For each case, seven data presence indicator variables identify the presence of data in each of the data file types. Four observation variables identify the number of case-months records observed in the Four County Cases file, the number of person records observed in the Four County Persons and Assistance History Persons files, and the first month during which AFDC participation is observed in the Assistance History Persons file. Fifteen survey detail variables identify survey participation, interview completion, respondent's person number and date of birth, and the survey record number. Parts 2-5, Four County Data: Cases, contain case-month records for all control and experimental cases selected to be a part of the study between October 1992 and March 1997 for any month (beginning with the month selected) during which an assistance unit received AFDC of food stamps. Each case-month record contains county administrative data for eligible family size and type, income, and cash and food stamp assistance amounts. These files are identical to the Four

County Data: Cases files in County Welfare Administrative Data Version 4. Parts 6-9, Four County Data: Persons, contain records for each person observed associated with any control or experimental case selected to be part of the study between October 1992 and March 1997. Records include nonconfidential demographic information and monthly values for aid type and eligibility. These files are identical to the Four County Data: Persons files in County Welfare Administrative Data Version 4. Parts 10-13, Assistance History Data: Aggregate, contain case-month records that summarize information for the months of January 1987 through December 1996 about the public assistance program participation and eligibility of persons associated with sampled cases. This dataset was constructed from the Assistance History Data: Persons datasets (Parts 14-17) that contain persons associated with the study units. Parts 14-17, Assistance History Data: Persons, contain the Medi-Cal and program participation history of each person associated with the assistance units for cases selected between October 1992 and March 1997. This dataset does not include information about persons who left the assistance unit before the month sampled. Each record includes program participation information for each month from January 1987 through December 1996, a total of 120 months, as well as demographic information. Parts 18-21, Medi-Cal Payments Data: Cases, contain one record for each case selected to be part of the CWPDP sample between December 1992 and March 1997. This dataset contains the Medi-Cal payments made for each case in the study for the month of December 1992 and quarterly from 1993 through the fourth quarter of 1997. University of California Data Archive and Technical Assistance receives this data from California Department of Social Services-Research Branch (CDSS-RB) by quarter (not month), aggregated to case number. Therefore, the data in these files are aggregated payments information for all assistance units with the same case number, whether or not that assistance unit is part of the CWPDP sample. These files are identical to the Medi-Cal Payments Data: Cases files in County Welfare Administrative Data Version 3.

Data Collection Notes: (1) Administrative data, such as the files represented here, must be viewed in light of the original reasons for which the data were collected, as well as the original data systems used to collect and store the data. These data were collected for the purpose of administering a state assistance program. Without some understanding of the context of Welfare programs in California, users of these data may have difficulty conducting contextually meaningful analysis. Because of the interrelated nature of the files represented here, users are strongly advised to examine carefully the entire set of available files before beginning analysis. (2) The principal investigator delivered this data with the following note about the current version: This Version 4.1 of the County Welfare Administrative Data replaces all previous versions. The files in Version 4.1 correct a coding error in both the Version 4 Assistance History Data: Aggregate files and the Version 4 Assistance History Data: Persons files. Variables in the Overview Data: Cases files that relate to these two sets of data were also changed to reflect the corrections made to the Assistance History Data files. Also note that the files in Version 4 cover a longer data period than in Version 3. Four County Data files now contain 12 additional months of data through September 1998. Assistance History Data files contain two additional years of data.

Methodology

Sample: Cases were sampled from the administrative welfare records sent by each county to University of California Data Archive and Technical Assistance.

Weight: For original sample cases, the weight was based on the sampling interval. The weight variable for additional sample cases was modified to account for undersampling of new sample cases due to the delayed entry of cases into the Medi-Cal Eligibility Data System (and, therefore, into the sampling pool). In Version 4, two weights were included for each case: the Sampling Interval Weight and the County

Caseload Weight. The Sampling Interval Weight is the original weight implied by the sampling method. The County Caseload Weight is the weight needed to expand the original sample to the December 1992 caseload (for county-aid code cells) and to expand the additional samples to the number of new approvals (for county-aid code cells) during the sample month. Using state administrative data, County Caseload Weights were calculated by the principal investigator staff to reflect the number of AFDC cases a sample case represents. Expanding the original sample cases by using the County Caseload Weights, more accurately reflects the caseloads of the counties during December 1992. Similarly, expanding the additional sample cases by using the County Caseload Weights, more accurately reflects the number of new cases in the counties during the month selected for sample. After December 1992, it is not possible to weight up samples to determine county caseloads since certain types of cases were excluded from sampling. Additional sample cases can only be expanded to the number of cases new to welfare during the study period.

Introduction

Overview of the California Work Pays Demonstration Project

In December 1992 the State of California initiated the California Work Pays Demonstration Project (CWPPD) to assess the effects of recent changes in AFDC provisions. The data files described here represent a collaborative effort of the California Department of Social Services Research Branch (CDSS-RB), the University of California Data Archive & Technical Assistance (UC DATA) and the Survey Research Center at the University of California, Berkeley. The goal of the project is to document the dynamics of family poverty and welfare use in California. The CWPPD is collecting and integrating data on the individual, household, welfare and employment characteristics of AFDC recipients and households, during and after their participation in the welfare system, from four separate sources:

- State administrative records for AFDC, Medi-Cal, Unemployment Insurance, other state and federal assistance programs, and employment tax files.
- County administrative records for AFDC and Food Stamps programs.
- Non-automated client records and paper files at county welfare offices.
- Telephone interviews with AFDC recipients.

By combining these various datasets, it will be possible for researchers with an interest in welfare, poverty, employment and family research to obtain unusually detailed information about the characteristics and economic behaviors of low-income families and children in California. Researchers will be able to examine family outcomes, such as income and family stability, and their relation to household characteristics and involvement in state and federal assistance programs. Transfer payment and earnings data will be available for researchers interested in cost comparison and cost benefit analyses of social programs.

Overview of the CWPDP—County Welfare Administrative Data

The County Welfare Administrative Data (CWAD) consists of the administrative welfare records for sample cases which each county social services department sends to UC DATA on a monthly basis. In addition, CDSS provides history data on sampled persons. UC DATA selects variables and merges the case-month information to create the database. The CWPDP County Welfare Administrative Data (CWAD) consists of four types of data, based on the coverage of the dataset:

- **Overview Data:** Case-level records identifying presence of data in CWAD administrative data files and survey data files.
- **Four County Data:** Monthly administrative data collected at the county level for the period from December 1992 through September 1998.
- **Assistance History Data:** Assistance data from 1987 through 1998 collected from the Medi-Cal Eligibility Data System on persons in the CWPDP sample.
- **Medi-Cal Payments Data:** State administrative Medi-Cal payment data from December 1992 through the Fourth Quarter of 1997 for CWPDP sample cases.

Each of these groups of data are further divided into either case or person files based on the unit of analysis, resulting in a total of six datasets, in four groups, at two levels of analysis:

- Overview Data—Cases
- Four County Data—Cases
- Four County Data—Persons
- Assistance History Data—Aggregate
- Assistance History Data—Persons
- Medi-Cal Payments Data—Cases

Two additional SAS programs are included: fcc41cr.sas converts the Four County–Cases Data to a “wide” file format; aha41cr.sas converts the Assistance History–Aggregate Data to a “wide” file format. For months during which no data are present, SAS missing values are entered by the program.

Notes on Using The Data

This Version 4.1 of the County Welfare Administrative Data replaces all previous versions.

Introduction

The information contained in this section is designed to highlight aspects of these data which require careful attention by the researchers using these files.

Administrative data, such as the files represented here, must be viewed in light of the original reasons for which the data were collected, as well as the original data systems used to collect and store the data.

These data were collected for the purpose of administrating a state assistance program. Without some understanding of the context of Welfare programs in California, users of these data may have difficulty conducting contextually meaningful analysis.

Because of the interrelated nature of the files represented here, we strongly advise users to carefully examine the entire set of available files before beginning analysis.

Changes Since Version 4

Correction to Assistance History Data files and Overview Data files

The files in Version 4.1 correct a coding error in both the Assistance History Data — Aggregate Data and the Assistance History Data -- Persons files. Variables in the Overview Data — Cases Data that relate to these two sets of data were also changed to reflect the correction made to the Assistance History Data.

Changes Since Version 3

Data Period

The files in Version 4 cover a longer data period than in Version 3. Four County Data files now contain 12 additional months of data through September 1998. Assistance History Data files contain two additional years of data.

Linking Files

Researchers may wish to do analyses combining, or linking, data from these files. To do this, it is necessary to uniquely identify each record in the files. This section describes the unique identifier to "link" records from separate files. **Linking data files is a complex process. Careful thought must be given to the procedure used.** Finding a match on the identifier means that you have successfully located information for the unique record in each of the files. The following chart defines the combination of variables in each file which uniquely identify the records.

CWAD Case Identification Number (CIDG)

Version 4 of the CWAD contains data for 20,963 sampled cases. Each sampled case has a unique CWAD Case Identification Number (CIDG).

Assistance Unit Number (ASUC)

Assistance Unit Numbers are important for Alameda County and Los Angeles County data. Multiple assistance units may be affiliated with sample cases in these counties. Distinct assistance units are identified in the Four County Data files using this variable. In the FCC files, two or more records may exist for a given Accrual Month for a unique CWAD Case Identification Number, if more than one assistance unit exists. In addition, more than one record may exist for an individual person if data for the person was found affiliated with more than one Assistance Unit Number. Records in the Overview Data, Assistance History Data, and Medi-Cal Data are aggregated to the CWAD Case Identification Number level and do not contain an Assistance Unit Number.

Accrual Month (MONG)

Case-month records in the Four County Data–Cases and Assistance History Data–Aggregate are distinguished by the Accrual Month (MONG) variable. In the Four County Data–Cases files, only one record for each assistance unit, identified by CWAD Case Identification Number (CIDG) and Assistance Unit Number (ASUC), may exist for each accrual month from December 1992 through September 1998. In the Assistance History Data–Aggregate files, one and only one record for each case, identified by CWAD Case Identification Number (CIDG), exists for each accrual month from January 1987 through December 1998.

CWAD Person Number (CPNG)

CWAD Person Numbers are intended to uniquely identify records associated with sample cases. In Alameda County and Los Angeles County, a single individual may have multiple records because of multiple assistance units; each record will have a different CWAD Person Number. In addition, some records may appear to identify the same person: an individual may have multiple records if the county person number associated with that individual changed over time. UC DATA attempted to identify and merge matching records, but it is unlikely that all matches have been captured.

Linking Survey Files

In addition to the CWAD administrative data files, the CWPDP included telephone interviews with AFDC recipients. Data from these interviews can be found in the following Public Use files:

Cases in the survey files are uniquely identified by the Case Identification Number (CASEID). Cases in the CWAD files are uniquely identified by the CWAD Case Identification Number (CIDG). To link a survey file with the CWAD files, you must use the CWAD Overview Data file as a crosswalk. The Case Identification Number (CASEID) in the Survey file is identical to the Survey Identification Number (SIDG) found in the

CWAD Overview Data File. The CWAD Overview Data File links the Survey Identification Number (SIDG) with the CWAD Case Identification Number (CIDG).

Linking the Data Validation Case Coding File

The CWPDP also includes a data validation case coding Public Use file:

- *California Works Pays Demonstration Project: Data Validation Case Coding Data Public Use Version 5*

This file links directly to the CWAD files by matching the CWAD Case Identification Number (CIDG) that appears in both files.

Dataset Overlap

Because of additional case sampling, inaccuracies in county administrative data, and subsampling for survey and data validation, not all cases are observed in all CWAD datasets. Researchers should pay close attention to data periods and case sampling periods for each datasets used. The data presence indicator variables found in the Overview Data file provide easy identification of cases found in the various datasets.

The following table summarizes the indicator variable values. The first three digits of each variable are the abbreviation for the dataset indicated (e.g., FCC refers to the Four County Data–Cases. In the following table, the cell value indicates the number of cases contained in both data sets corresponding to the cell. For example, 20,576 unique cases are found in the Four County Data–Cases and Four County Data–Persons datasets.

Notes on Datasets

Variable Naming Convention

The variable names contain information about the source of the data, to aid in distinguishing between the sources of different variables that represent similar characteristics or quantities. Variable names are short to allow for the conversion of case-month records to case records.

Variable names have the following format: VVVFDDDD where

VVV represents the variable label,

F represents the Source File, and

DDDD represents the time period in YYMM or YYQQ format.

Source files may be identified as follows:

G represents Global variables which do not vary within cases across files,

C represents County Case Records,

P represents County Person Records,

A represents Assistance History - Aggregate Records,

H represents Assistance History - Person Records,

M represents Medi-Cal Payments Records, and

The names of variables with no date distinction are four characters long.

Variable names for the accompanying survey files and data validation case coding files have not been similarly changed at this time.

Weight Variables

For original sample cases, the weight was based on the sampling interval. The weight variable for additional sample cases was modified to account for under sampling of new sample cases due to the delayed entry of cases into the Medi-Cal Eligibility Data System (and, therefore, into the sampling pool). In Version 4, two weights are included for each case: the Sampling Interval Weight and the County Caseload Weight. The Sampling Interval Weight is the original weight implied by the sampling method. The County Caseload Weight is the weight needed to expand the original sample to the December 1992 caseload (for county-aid code cells) and to expand the additional samples to the number of new approvals (for county-aid code cells) during the sample month. See *Appendix D: Weighting Procedures* for additional information.

SAS Setup Programs

The SAS program templates to read in the data files have been improved from earlier versions. First, formats have been included for more variables. As the template is written now, the formats are part of the variables in the dataset. Researchers who choose to use these formats will need either to store the formats in a permanent library or to include the format code when using the datasets. Second, the programs have been altered to read date fields as SAS dates. As most of the date fields have the form YYMM and the SAS setup will read these dates as YYMM01, representing the first day of the month. In the Assistance History - Person data file, the Date of Birth - Century Digits variable has been incorporated into the Date of Birth field to create a SAS date, and eliminates the field as a separate variable. Third, the SAS setup will read values representing missing data as SAS missing values. Numeric missing values can be identified by the SAS numeric missing (.) and character missing values can be identified as a blank between quotation marks (" ").

SAS Wide File Setup Programs

Two SAS program templates are included in this release to aid users who wish to convert the case-month records of the Four County Data - Cases data files and the Assistance History Data - Aggregate data files to case level records. The programs convert the data variables to variables with the same name, except that in the case records the variable name has an additional 4 digits that indicate the accrual month in YYMM form. See Variable Naming Convention. For example, the data for County code - Month (MCCC in the Four County Data - Case files) for accrual month 9212 will be found in the variable MCCC9212 in the case record.

The Overview File

The Overview file includes sample cell variables, variables indicating whether or not the case is observed in each of the file types, counts of months observed in the FCC files, persons observed in each of the persons files, a variable identifying the first history month of AFDC receipt for the case, survey subsample variables and the survey identification number. This file allows users to identify cases for which there is not the full complement of records and variables.

Cases with the following CWAD Case Identification Numbers (CIDG) were erroneously surveyed in the CWPDP Survey: Interviews 1997-1998 January 1995 - August 1996 Sample (Combined Wave). These cases were not sampled between January 1995 and August 1996. Disregard any survey records from the following cases, indicated by the CIDG and SIDG pairs below:

Four County Data–Cases

Case-month records are included only for months during which UC DATA observed that the case or assistance unit received an AFDC payment and/or received food stamps.

Dollar amounts were transcribed as observed in the original county data. As a result, some negative or exceptionally high dollar amounts can be found in the data. Dollar values missing systematically (e.g. data not available or missing records) were coded as '99999'. Similarly, case management dates (e.g. ADTC, FDTC) before 1992 can be found in the data.

The San Bernardino County data allowed UC DATA to identify AFDC payments and Food Stamp coupons never redeemed by recipients. Non-redeemed AFDC payments are included in the CWAD data; non-redeemed Food Stamp coupons are not included in the CWAD data for this county.

Because historical information is available in San Bernardino County data, data for additional sample cases may appear one or two months before the Month Selected for Sample (MOSG). This finding suggests the administrative delay in sampling new cases may result in two months of missed payments in the other three research counties.

A number of idiosyncrasies have occurred with the San Joaquin County administrative data. During the study period, the San Joaquin County Department of Social Services began using a new computer records system, the Statewide Automated Welfare System (SAWS). CWPDP experimental case were entered into the new system. Because the SAWS system could not accommodate 2 different payment schemes, control cases were not entered into the SAWS system. One data element available in the old system - Food Stamps Household Size (FSZC) - is not available in SAWS, and two previously unavailable data elements- Food Stamp Dependent Care Cost Deductions (FDEC), Food Stamp Excess Shelter Cost Deductions (FEXC) - are available in the SAWS system.

Large increases in the number of Experimental status case-month records in San Joaquin County occurred in January 1994 and November 1995. UC DATA verified that these case records were accurate as sent by the county but has been unable to determine the reason for the increase.

Four County Data–Persons

Problems with the county data were occasionally experienced. A large number of Los Angeles County person records were missing from the December 1992 files. A similar problem occurred in Alameda County during April 1996. As a result, variables for these months will contain a disproportionately large number of missing values.

San Joaquin County administrative persons data does not identify monthly AFDC and food stamps eligibility.

Monthly county administrative person records were matched across months using County Case Number, Assistance Unit Number and Person Number. Because the person number for an individual may change over time, UC DATA attempted to match records using combinations of first name, social security number and date of birth values. When two of these three variables matched, the records were assumed to refer to the same individual, and the records were merged. It is likely that not all person number changes were captured by this method.

A person observed in the Four County Data – Persons files as being in multiple assistance units under the same case was given multiple CWAD Person Numbers (CPNG). As a result, this person has multiple records in the Four County Data – Persons files and the Assistance History Data – Persons files.

Assistance History Data–Aggregate

The data in these files was created by aggregating person records found in the Assistance History Data - Person Files. As a result, historical information about cases is constructed only from records of individuals observed in the county administrative data following sampling. Data for individuals who left sampled cases prior to sampling are not observable, and therefore, the Assistance History Data suffers from this lack of coverage. Please see the notes under Assistance History Data - Persons for further information about this data.

Some persons, identified by a combination of CIDG and CPNG, from the Assistance History Data – Persons files were not included in the counts for the Assistance History Data – Aggregate files. Any person without a date of birth, either DOBH or DOBP, was excluded.

A person observed in the Four County Data – Persons files as being in multiple assistance units under the same case was given multiple CWAD Person Numbers (CPNG). As a result, this person has multiple records in the Four County Data – Persons files and the Assistance History Data – Persons files.

People in multiple assistance units under a single case with multiple records in the Assistance History Data – Persons files were treated as a single record during aggregation. This avoids multiple counting of the same person in a case unit.

The counts in the Assistance History Data —Aggregate Files count distinct categories of assistance or eligibility separately for both adults and children. It is possible to sum up the counts of distinct assistance categories and obtain the total counts of adults or children. It is also possible to do this with distinct eligibility categories.

Specifically for categories of assistance:

Assistance History Data–Persons

Individuals are identified by Social Security Number in the Medi-Cal Eligibility Data System. CWAD Case Identification Numbers are assigned based on the observation of the individual in county administrative data. As a result, it is possible that an individual observed on assistance or Medi-Cal eligible prior to sampling may actually have been assisted or eligible as part of another welfare or Medi-Cal case. Observing that a person was on aid at a particular time means only that the person was on aid in some case.

Any person associated with a case prior to sampling but not after sampling is not identifiable and is therefore not included in the Assistance History Data. Only individuals observed in the county administrative data

following case sampling are observable. Assistance History Data are included for all persons observed in the county administrative data and observed in the Medi-Cal Eligibility Data System. The Person Sampled variable (PESG) identifies individuals observed receiving aid at the time the case was sampled. A Person Sampled variable value of zero indicates the person was not receiving aid at the time of sampling, but data for this person was observed in the county administrative data.

A person observed in the Four County Data – Persons files as being in multiple assistance units under the same case was given multiple CWAD Person Numbers, CPNG. As a result, this person has multiple records in the Four County Data – Persons files and the Assistance History Data – Persons files.

Persons found to be associated with more than one sampled case will have multiple records in the Assistance History Data – Persons files. These people will have identical records with identifying information from each of the sampled cases. The records will be identical because AHP files do not separate out program participation and eligibility for the multiple cases a person may be associated with over time. This may also mean that a person can be found in more than one AHP county file, if the person was associated with sampled cases from more than one research county. There is no identifier linking a person across cases or across assistance units under one case. One person may have multiple CWAD Case Identification Numbers (CIDG) and multiple CWAD Person Numbers (CPNG). This phenomenon is rare.

Although there are records for persons in cases sampled in March 1997, almost none of these persons were matched to the Medi-Cal Eligibility Data System. In general, only persons in cases sampled through February 1997 were matched to MEDS. The variable MEDS Match Identifier, MMIH, indicates whether the person was matched or not.

The aid code value '3R' indicates that this person is part of the California Work Pays Demonstration Project and exempt from the AFDC grant reductions. Only control cases are exempt from the grant reductions, however, we do observe people in experimental cases with the aid code value '3R'.

Refer to *Appendix H: Recoding of Assistance History Data from MEDS Files* for information about missing values.

Medi-Cal Payments Data–Cases

For cases sampled after the second quarter of 1995, Medi-Cal payments data are not available for quarters prior to the quarter in which the case was sampled. Missing data for prior quarters is coded '999999'.

Appendix A: Legislative Changes

Legislative Changes

State legislation under the Assistance Payments Demonstration Project mandated specific statewide reforms in California's welfare program. The legislation provided authority to the Department of Social Services to make programmatic changes in AFDC. The following changes became effective December 1, 1992:

- (1) the Maximum Aid Payment (MAP) was reduced by a total of 5.8 percent; and
- (2) the 100-hour work rule was waived for unemployed parent cases. (This rule was not in effect for family group (FG) cases.) This means that beginning December 1992, earners in both family group (FG) and unemployed parent (U) cases may work more than 100 hours in any given month and not automatically be disqualified for aid.

Additional changes were made in California's welfare laws in July of 1993 when Senate Bill 35 passed. The California Work Pays Demonstration Project continued the APDP changes and included additional work incentives:

- (3) rescinding the four-month limitation on the \$30 and 1/3 income disregard, meaning that beginning July 1993, aid recipients may work and not have their grants reduced dollar-for-dollar; rather, recipients can keep the first \$30 and one third of their income before aid reductions ensue;
- (4) increasing the need standard—the Minimum Basic Standard of Adequate Care (MBSAC) to allow income produced from employment;
- (5) increasing the Earned Income Tax Credit; and,
- (6) further reducing the Maximum Aid Payment, to a total of 8.3% (including the cuts made previously).

Other Senate Bill 35 changes provided:

- (7) a child care supplement for AFDC recipients who work, applicable to all recipients;
- (8) expansion of the Greater Avenues for Independence (GAIN) program by 71 percent to allow 36.6 percent more AFDC recipients to be served. A "one time through" provision was also added to the program, and a one-time only exemption for having a child under the age of three years;
- (9) changes in resource limits: The equity value limit for an automobile increased from \$1,500 to \$4,500; allowable resources increased from \$1,000 to \$2,000; and savings accounts for specialized purposes became possible: up to \$5,000 for children's college education, for a down payment on a home, or for starting a business (resource limit changes do not apply at eligibility determination, for which the old rules still apply);
- (10) an alternative assistance feature, whereby people who qualify for welfare do not have to receive a grant if they do not want one, but rather can receive only the Medi-Cal insurance coverage, child care assistance, and other help instead;
- (11) a program for pregnant and parenting teens called Cal-Learn, featuring incentives to return to or stay in school, disincentives to bad grades or dropping out and the provision of child care, transportation, and ancillary assistance necessary to support schooling; and case management services through a specialized agency known as the Adolescent Family Life Program (AFLP).

Refer to *Appendix F* for information about additional MAP and MBSAC adjustments

In January 1998 the California Work Pays Demonstration Project ended. Provisions that previously applied only to experimental cases now applied to all cases. California's new welfare program, CalWORKs, also began at this time. In response to federal welfare reform, work requirements and five-year time limits for welfare receipt were imposed on welfare recipients.

Appendix B: Research Design

Research Design

In order to enact changes to welfare, the State of California was required in 1992 to obtain a federal waiver because federal regulations prohibit reducing AFDC payments by the amount the state proposed. One condition on which the federal government signed the waiver was that after a two-year grace period, the State would reimburse the federal government for excess costs if the changes were not cost neutral to the federal government. Another condition was that the State would conduct research on the effects of changes in welfare provisions on recipients with respect to the achievement of self-sufficiency. In order to determine whether the welfare rule changes have been cost neutral to the federal government and to conduct research, the state established the California Assistance Payments Demonstration Project, later renamed the California Work Pays Demonstration Project (CWPPD).

UC DATA was asked to design and implement a series of different data collection strategies to provide information for an evaluation study with an experimental research design. Accordingly, 15,000 cases on AFDC in four counties (Alameda, Los Angeles, San Bernardino, and San Joaquin) were randomly selected for the study. These initially selected cases are referred to as the "original" sample. Ten thousand cases were placed in an experimental group which, like the rest of the welfare population, was subject to the rule changes, and five-thousand cases were kept on the rules that were fixed as of September of 1992. For these control cases, it was as if the welfare law never changed. U—or unemployed parent—cases (which are two-parent families) constitute only 5-7% of the welfare caseload, but they have been oversampled for the CWPPD experiment because as a group they are expected to be more responsive to the work incentive features of the program. One-third of the CWPPD sample was drawn with this aid type.

Though an initial sample of 15,000 cases was drawn, many recipients leave welfare as time goes by. Because of this case turnover, the original sample resembles the actual welfare population less and less over time. Therefore, in addition to the base (original) sample, each month UC DATA adds new sets of freshly-drawn cases from CDSS. These subsequently selected cases are referred to as the "additional" samples.

The Research Counties

The research counties were selected based on geography and population type, with one urban county from the northern and southern parts of the state and one rural county from the northern and southern parts of the state.

The four counties chosen as research counties for the CWPPD have distinct characteristics relating to their geography, populations, welfare caseloads, and welfare departments. Los Angeles and Alameda Counties contain major urban centers of California, and San Joaquin and San Bernardino Counties are their neighboring rural areas. San Joaquin represents the agricultural region known as the Central Valley, while San Bernardino is part of Southern California's vast desert region and is the largest of the four counties in geographic size.

Los Angeles County has the largest population of any California county with nearly nine million residents in 1990. San Bernardino and Alameda Counties, with approximately 1.2 to 1.5 million residents each, contain less than one-sixth of the population of Los Angeles. San Joaquin with approximately 500,000 residents contains less than one-eighteenth of Los Angeles' population.

Los Angeles County has the highest welfare caseload, with more than 285,000 cases in 1992; the other three counties have caseloads in the 30,000 - 60,000 range with San Joaquin's caseload being the smallest. However, San Joaquin County had the highest percentage of its population on AFDC of all four counties in 1990. In addition, San Joaquin County is unique because it has a high percentage of unemployed parent cases (20%). The other three county caseloads contain 10 to 15 percent unemployed parent cases.

Appendix C: Sample Design

In December 1992 the State of California initiated the California Work Pays Demonstration Project (CWDP) to assess the effects of recent changes in AFDC provisions. This field experiment with control and experimental groups was required under the Federal waiver that permitted the changes in AFDC program rules. The waiver specified that the original sample should consist of approximately 10,000 experimental and 5,000 control cases. In addition, new cases were to be selected for study as an attempt to maintain a representative sample of the AFDC population across time and obtain information about new welfare cases.

Procedures For Original Sample Selection

Selection of the CWDP sample was completed by the California Department of Social Services. The pool of cases eligible for sampling included all Family Group (FG) and Unemployed (U) cases receiving AFDC in each of the four research counties in October 1992, except mixed FG/U cases¹, as recorded in the Medi-Cal Eligibility Data System (MEDS) files². The original December 1992 sample of approximately 15,000 cases was to consist of approximately 4,000 FG and 2,000 U cases from Los Angeles County, and 2,000 FG and 1,000 U cases for each of the remaining three counties. To select the original sample, CDSS first raised the county targets by approximately 10 percent because of the likelihood that some cases would be lost between the sampling month, October, and the month the experiment began, December. CDSS then calculated the appropriate sampling intervals to exhaust the actual October 1992 county caseloads in selecting the sample. These intervals were rounded down to generate a higher number of cases than the sample targets. The first case was selected by a random number generator and the sampling intervals exhausted the actual October 1992 county caseloads. Sampled cases were then randomly assigned to control or experimental status (1 control case for every 2 experimental cases). Because the caseloads were sorted by county case number, the use of the interval sample served to stratify the original sample by age (time on assistance) of case since numbers are assigned by counties sequentially as cases come on the welfare rolls. Therefore, the distribution of sampled cases by length of time on aid should match that of the county caseloads in October 1992. The following table shows that the original observed sample was actually 16.2% lower than the expected sample using the rounded interval, and 12.8% lower than the sample target using the non-rounded intervals.

Procedures For Additional Samples Selection

Additional sample cases were selected to provide information about households new to assistance in the research counties each month. The additional cases were sampled on a monthly basis from cases "new" to the AFDC program. In addition, new cases were to be selected for study as an attempt to maintain a representative sample of the AFDC population across time and obtain information about new welfare cases. Because the first additional sample was not selected until March 1993, it was necessary to include "new" cases from the period December 1992 through February 1993. For the March 1993 additional sample, cases were considered "new" if they had not received assistance during September, October or November 1992. For cases sampled in the period March 1993 through November 1993, a case was considered "new" if it had not received assistance at any time between the sampling month and September 1992. After November 1993, a case was considered "new", and eligible for inclusion in the additional sample if it had not received assistance at any time during the previous 12 months. CDSS then selected additional sample cases, from these "new" cases, using the same sampling intervals used for the original sample. The last month cases were selected for inclusion in the CWPDP sample was March 1997.

Appendix D: Weighting Procedures

Weights in the CWAD depend on County, Original Aid Code, Control/Experimental Status and Month Selected for Sample. Two weights are provided on each CWAD record.

Sampling Interval Weight

The Sampling Interval Weights are based on the sampling intervals for the Original County Code, Original Aid Code, and Control/Experimental Status of the case. Sampling Interval Weights do not depend on the Month Selected for Sample.

County Caseload Weight

Because of delays in reporting new cases to CDSS and other difficulties, the pools of new cases considered for sampling have been consistently smaller than the actual number of cases eligible for sampling. As a result, expanding the data using the Sampling Interval Weights will underestimate the actual county caseload experience; the Sampling Interval Weights are too low for the case samples. Using state administrative data, County Caseload Weights were calculated by UC DATA staff to reflect the number of AFDC cases a sample case represents. Expanding the original sample cases using the County Caseload Weights more accurately reflects the caseloads of the counties during December 1992. Similarly, expanding the additional sample cases using the County Caseload Weights more accurately reflects the number of new cases in the counties during the month selected for sample. After December 1992, it is not possible to weight up samples to determine county caseloads since certain types of cases were excluded from sampling³. Additional sample cases can only be expanded to the number of cases new to welfare during the study period.

Note: Sampling Interval Weights and County Caseload Weights should not be used when Control and Experimental Cases are combined in the analysis.

Combining Control and Experimental Cases

The weights provided in the data files include different weights for control and experimental cases. Taken separately, the control sample and the experimental sample each expand to reflect county caseload experience. Thus, the original control sample sizes for counties and aid types can be expanded to reflect the caseloads for each county and aid type in December 1992. Similarly, the original experimental sample sizes can be expanded to reflect these numbers as well.

Because selection to the CWAD sample depended only on county and aid type and random assignment to control and experimental groups occurred after sampling, combined sample weights (not provided) should be equal for control and experimental cases from the same county and aid type. Combined sample sampling interval weights are shown in the following table *CWAD Original Sample Design*. To determine combined sample county caseload weights for additional sample cases, County Caseload Weights found in the data files should be multiplied by 2/3 for experimental cases and 1/3 for control cases. When combining control and experimental cases for analysis, the weights for cases with the same Original County Code, Original Aid Code, and Month Selected for Sample should be equal. **Combined Sample Weights are not included in the data files.**

³ For example, inter-county transfers are excluded because they are not "new" to the CWPDP welfare rules, and could not be randomized to control or experimental status.

Appendix E: Grant Calculation, Eligibility, and Income Variables

Grant Calculation

Calculation of AFDC Grants

AFDC grants are calculated based on the number of eligible persons in the assistance unit and the amount of net nonexempt income received by the assistance unit during the accrual month. The number of eligible persons in the assistance unit determines the Maximum Aid Payment (MAP) and the Minimum Basic Standard of Adequate Care (MBSAC). The MBSAC is larger than the MAP and the difference is the amount of non-exempt income less all applicable disregards which an assistance unit can receive without experiencing a reduction in the benefit amount. See the discussion below of AFDC Net Monthly Income and income deductions. The basic AFDC grant payment is determined as the smaller of the MAP or the MBSAC less AFDC Net Monthly Income. Thus, if AFDC Net Monthly Income is less than the difference between the MAP and the MBSAC, the amount of the basic grant will be the MAP. The basic grant payment may be increased to cover any applicable special needs or supplemental amounts or reduced to recoup funds overpaid in a previous month.

Note regarding the 185% Income Limit for Eligibility: The assistance unit is ineligible for AFDC during any month in which the total reported or anticipated gross income and any deemed income exceeds 185% of the sum of the Minimum Basic Standard of Adequate Care plus the value of any special needs.

Calculation of Food Stamp Benefits

Food stamp benefits are calculated based on the number of eligible persons in the household and the amount of net income received by the household after deductions during the accrual month. Net income includes the sum of all earned income, all cash assistance income, and all other unearned income. Deductions from this sum include an earned income deduction of 20% of earned income, a standard deduction of \$127 per household (in 1992, adjusted annually), a dependent care costs deduction of up to \$160 per dependent per month, an excess shelter costs deduction of up to \$200, and a deduction for excess medical expenses. The household size, equaling the number of eligible persons in the household, determines the maximum amount of food stamp coupons available to the household. 30% of the net monthly income amount is subtracted from this maximum to determine the monthly food stamp benefit.

Eligibility of Household Members

AFDC Federal Eligibility

Federally eligible children include all children who are deprived of parental support and care due to the death, incapacity, or continued absence of a parent, or the unemployment of a parent who meets federal eligibility conditions. A child meets the age requirement for AFDC eligibility until his/her 18th birthday. A child 18 years of age is eligible for AFDC only if he/she is enrolled as a full-time student in high school, or if he/she has not graduated from high school, and is enrolled in a vocational or technical training program which cannot result in a college degree, provided he/she can reasonably be expected to complete either program before reaching age 19.

Federally eligible adults include the caretaker relative of any federally eligible child or of a child receiving SSI/SSP who would otherwise be federally eligible, the second parent of a federally eligible child when the deprivation of at least one child is the incapacity or unemployment of a parent who meets federal eligibility conditions, and the spouse of an incapacitated caretaker relative when the caretaker relative is the parent of a federally eligible child. A federally eligible pregnant woman is a pregnant woman who has no federally eligible children, who has provided the county with medical verification of her pregnancy, whose pregnancy has reached the three-month period immediately prior to the month of anticipated birth, and whose child, if born and living with the mother, would have been federally eligible for AFDC in the month of payment.

Excluded Household Members: The following individuals residing within a household shall be included as a member of the household for the purpose of defining a household, but such individuals shall be excluded from the household for the purpose of determining household size, eligibility, or benefit level: ineligible aliens, individuals disqualified for refusal to provide a SSN, individuals disqualified for a program violation, individuals receiving SSI/SSP, and students enrolled in higher education who fail to meet the eligibility requirements in CDSS Eligibility and Assistance Manual 63-406.2.

AFDC State Eligibility

A state-only assistance unit of one without an eligible child shall be established when a pregnant woman meets all of the following conditions: medical verification of pregnancy is provided to the county; the pregnant woman and unborn child, if born and living with the mother, would be eligible for AFDC in the payment month; the pregnant woman is not eligible for federal AFDC; and the pregnant woman could not be included in another assistance unit.

Food Stamp Eligibility

A household may be composed of any of the following individuals or groups of individuals, provided that such individuals or groups are not residents of an institution: an individual living alone; an individual living with others, but customarily purchasing food and preparing meals for home consumption separate and apart from the others; a group of individuals who live together and customarily purchase food and/or prepare meals together for home consumption. Thus the following persons are considered part of the household for determining household size and income amounts (and not considered as a separate household): children under 18 living with a member of the household who has parental control; parents living with their natural, adopted or step children; children living with their natural, adopted or step parents; an individual living with the household who is a spouse of a member of the household; a boarder; a sibling living with their natural, adopted, half- or step brothers and/or sisters; a woman or woman with children who are temporary residents of a shelter for battered women and/or children; and an individual who is 60 years of age or older living with others who is unable to purchase and prepare meals. Nonhousehold members (persons not included as a member of the household) include roomers to whom a household furnishes lodging, but not meals, for compensation; live-in attendants; and other individuals who share living quarters with the household but do not customarily purchase food and prepare meals with the household. Household members excluded from eligibility include: ineligible aliens, SSI recipients, persons disqualified for program violations or workfare sanctions, individuals who fail to provide a social security number, and, generally, students enrolled at least half-time in an institution of higher education.

Income Variables**AFDC Gross Earned Income:**

AFDC Gross Earned Income equals the total earned income for assistance unit members and additional household members. Earned income is income received in cash or in-kind as wages, salary, commissions or profit from activities such as business enterprise, farming, etc., in which the recipient is engaged as a self-employed individual or as an employee, or income received as disability benefits. Exempt earned income which is not included in the AFDC computation includes earnings of a child derived from participation in JTPA programs, all earnings of a child under 19 years of age who is either a full-time student or a half-time student not employed full-time, income from the College Work Study Program, and the first \$50 of any child or spousal support paid to the assistance unit.

AFDC Net Nonexempt Earned Income:

Net earned income for the assistance unit equals the sum of net income for each assistance unit member, where net income for each individual is calculated as the sum of total earnings from wages and salaries, in-kind earned income, and net self-employment (gross self-employment less business expenses) less applicable disregards. Individual Gross Nonexempt Earned Income amounts can be reduced by various disregards, if applicable.

- 1) Work-Related Expenses Disregard: Each individual in the assistance unit with earned income is eligible for a \$90 work-related expenses disregard each month to cover expenses such as clothing and transportation necessary to work.
- 2) \$30 and 1/3 Disregard: Individuals with earned income may be eligible for a disregard of \$30 and 1/3 of remaining earned income or \$30 of earned income. For experimental cases, the \$30 and 1/3 disregard is applicable in all months after July 1993. For control cases, the \$30 and 1/3 disregard is available for 4 months, after which the \$30 disregard is available for 8 months.
- 3) Child Care Disregard: Each employed recipient receives a disregard for the reasonable and necessary costs of obtaining child care for a child in the assistance unit or care for an incapacitated individual in the assistance unit when the county determines that adequate dependent care cannot be provided during his/her working hours by a person in the recipient's assistance unit. For each child or incapacitated individual the amount of the dependent care disregard is the least of: (a) \$175 per child or incapacitated individual if the recipient is

employed or self-employed at least 100 hours and at least 13 days of the month (\$200 per month per child under age 2), or \$174 per child or incapacitated individual if the recipient is employed less than 100 hours and 13 days per month (\$199 per month per child under age 2); or (b) The amount paid for such dependent care; or (c) For child care the cost of securing such child care through a child care facility meeting the standards for licensing when the county determines that such a facility is currently available to the recipient and could be reasonably used by the recipient.

- 4) Deduction for Ineligible Alien Child Living in the Home: When an ineligible alien child is living with an eligible sibling or half-sibling, a deduction shall be allowed from his/her aided parent's income equal to the difference between the MBSAC for the assistance unit with the ineligible child included and the MBSAC for the assistance unit only.

AFDC Net Nonexempt Unearned Income:

AFDC Net Nonexempt Unearned Income equals the total of amounts received from Social Security, Railroad Retirement Benefits and other pensions, 10% of payment received for room and board, cash and full value of items provided in kind to the assistance unit by an unrelated adult, child or spousal support paid to the recipient and not forwarded to the county, lump-sum refunds of employer's share of retirement contributions, net income from WIN/PSE, death benefits, and loans available for current needs. The amount of educational loans and grants which must be used to cover educational costs such as tuition is exempt of inclusion in the net nonexempt unearned income amount.

AFDC Net Monthly Income:

AFDC Net Monthly Income equals the sum of AFDC Net Nonexempt Earned Income and AFDC Net Nonexempt Unearned Income. This amount is used in conjunction with the MAP and MBSAC to determine the monthly grant. The monthly grant is determined as the lesser of the Maximum Aid Payment and the Minimum Basic Standard of Adequate Care less the amount of AFDC Net Monthly Income.

Food Stamp Gross Earned Income:

Food Stamp Gross Earned Income equals the total household earnings from the wages and salaries of an employee, gross income from a self-employment enterprise excluding the cost of doing business, training allowances, payments to VISTA volunteers, JTPA earnings (unless earned by a dependent under 19 years of age), and strikers' benefits. Note: For food stamp benefit calculations, income from the rental of property, roomers and borders is considered earned income.

Food Stamp Cash Grant Income:

Food Stamp Cash Grant Income equals the amount of cash public assistance received by the food stamp household during the month. This amount is treated similarly to unearned income.

Food Stamp Unearned Income:

Food Stamp Unearned Income equals the total of other unearned income includes annuities, pensions, retirement or disability benefits, gross income minus costs from rental property, child support or alimony payments directly to the household, and educational scholarships, grants, and loans less mandatory fees. This amount does not include income from cash assistance programs.

Food Stamp Net Monthly Income:

Food Stamp Net Monthly Income equals the sum of Food Stamps Cash Assistance, Food Stamps Unearned Income, and Food Stamps Gross Earned Income, less applicable deductions. This amount and the food stamp household size are used to determine the amount of food stamps to be granted.

- 1) Earned Income Deduction: 20% of Food Stamp Gross Earned Income is deducted in calculating Food Stamp Net Monthly Income.
- 2) Dependent Care Costs Deduction: A deduction from total food stamp income of the actual cost of dependent care, not to exceed the maximum dependent care deduction, when such care is necessary for a household member to accept or continue employment, comply with training programs, or pursue education. The maximum deduction is \$160 per child per month.
- 3) Excess Shelter Costs Deduction: A deduction from total food stamp income of the monthly share of housing and utility costs in excess of 50% of the household's income after all other applicable deductions have been allowed, subject to a maximum excess shelter costs deduction of \$200. If the homeless shelter costs amount is used, the utility costs amount must be zero. The standard homeless shelter costs allowance is \$128.

Appendix F: AFDC MAP and MBSAC Schedules, 1992-1998

For control cases, the Maximum Aid Payment (MAP) and Minimum Basic Standard of Adequate Care (MBSAC) schedules did not change from 1992 to 1997. When the California Work Pays Demonstration Project ended in January 1998, there was no longer a distinction between control and experimental cases. The MAP and MBSAC schedules that previously applied only to experimental cases now applied to all cases.

For experimental cases, the Maximum Aid Payment was reduced in December 1992 by about 6%, in September 1993 by approximately 3%, and again in June 1996 by about 2%. Urban and rural counties began to receive different MAP and MBSAC amounts in January 1997. Alameda and Los Angeles counties were classified as urban counties (region 1), and San Bernardino and San Joaquin counties were classified as rural counties (region 2). In January 1997 the MAP was further reduced for urban counties by about 5%, and for rural counties by approximately 9%. Therefore, since December 1992 the MAP for experimental cases has been reduced by about 15% for urban counties, and 19% for rural counties. See chart below for MAP schedules.

The MBSAC for experimental cases was raised by about 2% on average in July 1993, and raised again in July 1994 by about 1%. From July 1995 to December 1996 the MBSAC was further increased by approximately 2%. In January 1997, the MBSAC was *reduced* for rural counties (region 2) by about 5%. In July 1997 the MBSAC for both rural and urban counties was increased by about 3%, and it was further increased in July 1998 by about 3% for both urban and rural counties. Therefore, since December 1992 the MBSAC for experimental cases has been increased by about 10% for urban counties and 5% for rural counties. See the following MBSAC schedules.

When creating the Assistance History Data Persons file, monthly Aid, Medi-Cal Eligibility, and County Codes were compared for consistency. Persons who are Medi-Cal eligible should have a valid Aid Code and a valid County Code. Likewise, persons with a valid Aid Code should be Medi-Cal eligible and have a valid County Code. When inconsistent Codes were found, variables were recoded according to the following conditions:

- 1) If record indicates the person had a valid Aid Code, was Medi-Cal eligible, and had a valid County Code during the month, no variables were recoded.
- 2) If record indicates the person had a valid Aid Code and was Medi-Cal eligible, but did not have a valid County Code during the month, the County Code was recoded to '000' for missing data.
- 3) If record indicates the person had a valid Aid Code and a valid County Code, but was Medi-Cal ineligible during the month, then Medi-Cal Eligibility Code was recoded to '-1' to indicate inconsistent data.
- 4) If record indicates the person had a valid Aid Code, but was Medi-Cal ineligible and did not have a valid County Code during the month, then a check for previous eligibility was made. If the person had not previously been on aid (since 1987), then Aid Code, Medi-Cal Eligibility Code, and County Code were recoded to 'MM', '-2', and '999', respectively. If the person had previously been on aid, then Aid Code, Medi-Cal Eligibility Code, and County Code were recoded to 'MM', '-3', and '998', respectively.
- 5) If record indicates the person did not have a valid Aid Code, but was Medi-Cal eligible and had a valid County Code during the month, then Aid Code was recoded to 'MM' for inconsistent data.

Recoding of Ethnicity

Each person record in the Persons History File contains an ethnicity code (ETHHy) for each year from 1987 through 1998. Because of changes in the coding scheme over time and data entry errors, some persons have different ethnicity codes across years. For research convenience, UC DATA added an additional variable "ETHH" to the Persons History File. This variable was created using the following conditions:

- 1) Generally, the "ETHH" variable was assigned the most frequent value among of the twelve "ETHHy" variables. In the case of a tie, the more recent value was selected.
- 2) If the value '4' for "Other Asian" and a code for a specific Asian ethnicity were the only values among the twelve "ETHHy" variables, the code for the specific Asian ethnicity was selected.
- 3) If no valid ethnicity code was found among the twelve "ETHHy" variables, "ETHH" was assigned '6' or '8' for no valid data.
- 4) If all twelve "ETHHy" codes were missing, "ETHH" was assigned '9' for missing data.
